




# **About construction management services**

- Construction management services (CMS), a vertical of the Firm, was specifically created to address companies experiencing growth through greenfield / brownfield expansions. Since the 'Capital Spend Cycle' for creating additional infrastructure does not repeat itself every year companies do not invest in such talents for a long period of time. This is coupled with the fact that Indian construction industry is yet to adopt the best practices, specially for quality and billing.
- With a diverse engineering team comprising of 100 engineers having an average experience of 15 years coupled with chartered accountants (CAs), S&T has been able to collaborate with clients to provide them with reasonable assurance on the billing and the quality of the construction.
